Mr. Jason Hursey introduced the following resolution and moved for its passage:

A RESOLUTION AUTHORIZING THE ADOPTION OF AN ALTERNATIVE METHOD OF APPORTIONING THE LOCAL GOVERNMENT FUND

WHEREAS, Revised Code Section 5747.53 provides that in lieu of apportioning the undivided local government fund by a method prescribed by Revised Code Section 5747.51 and 5747.52, that an alternative method of apportioning said fund may be approved by the Budget commission upon approval of such alternative method by the Board of County Commissioners, the legislative authority of the city, located wholly or partially in the county, with the greatest population; and a majority of the boards of township trustees and legislative authorities of the municipal corporations, located wholly or partially within the county, excluding the legislative authority of the city with the greatest population, and

WHEREAS, the Coshocton County Budget Commission has traditionally operated under the statutory formula provided by Revised Code Sections 5747.51 and 5747.52, and

WHEREAS, the traditional method of apportioning the funds have resulted in continued uncertainties about the financial distribution of the funds, and

WHEREAS, an alternative method of apportioning the fund would bring stability to the process by eliminating the uncertainties and would provide a better method of financial planning, and

NOW, THEREFORE, BE IT RESOLVED by the Village Council that the alternative method of apportioning the local government fund as described and outlined in Exhibit A, and fully incorporated herein, as a fair and equitable method

of apportioning the local government funds which is in the best interests of the Village of West Lafayette, and hereby approves said alternative formula.

This Resolution shall be declared an emergency for necessity of health, safety and welfare of the citizens of West Lafayette, Ohio. The reason for such necessity is that the deadline for filing this resolution with the county auditor is July 10, 2024. Therefore, this resolution shall be effective upon passage and signing by the Mayor.
