RESOLUTION REGARDING VILLAGE PARK USAGE, REPEALING ORDINANCES AND RESOLUTIONS IN CONFLICT HEREWITH

WHEREAS THE Village of West Lafayette Ohio's insurance company has indicated that the person handling the use of the village parks and release form has the authority of the Village; and

WHEREAS Municipal corporations have special power to sell or lease real estate or sell person property belonging to the municipal corporation, when such real estate or personal property is not needed for any municipal purpose under Ohio Revised Code Section 721.01.

THEREFORE, BE IT RESOLVED by the Council of the Village of West Lafayette, State of Ohio as follows:

SECTION I. The Village Administrator, Village Fiscal Officer, and/or Mayor will be the person who is authorized to sign the use and release form for use of the village parks. Reservation fees will be charged only for the right to use the desired facility. The fees for reservation is outlined on the Park Use & Release Form. These fees are designated for maintenance and upkeep of the facilities. Reservation forms can be picked up and turned in to the Village Administrative Office located at 113 East Railroad Street, during regular business hours.

The parks are still available for daily use at no fee. Meaning the parks are still open for public use and enjoyment.

The fee can be waived at the discretion of the Village Administrator and/or Mayor.

SECTION II. The Park Use & Release Form is attached hereto incorporated as a part of this resolution.

SECTION III. That said resolution will be in full force and effect according to law, upon passage by the Village Council, signed by the Mayor, and posting by the Fiscal Officer.

SECTION IV: The original Burt Park Agreement and Resolution, Resolution 2010-15, is included for record.
