

**A RESOLUTION DECLARING CERTAIN VILLAGE PROPERTY NO LONGER NEEDED FOR MUNICIPAL PURPOSES AS SURPLUS AND OBSOLETE AND AUTHORIZING DISPOSAL OF SAID SURPLUS AND OBSOLETE PROPERTY**

WHEREAS, the Village of West Lafayette Police Department is in possession of a Whelen 52” LED lightbar that was stripped from the 2020 Chevy Tahoe that was wrecked; and

WHEREAS, the lightbar does not fit any of the current police cruisers and is no longer needed for municipal purposes; and

WHEREAS, the Coshocton County Sheriff’s Office (CCSO) located at 500 N. Third St., Coshocton, Ohio is in need of a 52” LED lightbar for one of their cruisers; and

WHEREAS, Ohio Revised Code Section 721.15(C) provides that “[i]f the legislative authority of the municipal corporation determines that municipal property is not needed for public use, or is obsolete or unfit for the use for which it was acquired, and that the property has no value, the legislative authority may discard or salvage that property;” and

WHEREAS, the Village of West Lafayette has determined that the lightbar is municipal personal property that is not needed for public use and is obsolete or unfit for the use for which it was acquired, and that the property has no value, and therefore it is appropriate for the legislative authority to discard or salvage that property; and

WHEREAS, the lightbar could be used by the CCSO.

NOW, THEREFORE, BE IT RESOLVED by the Council of West Lafayette, Ohio that:

SECTION 1. Consistent with the provisions of the Ohio Revised Code, Section 721.15 and any applicable codified ordinances, the following equipment is declared surplus, no longer needed for municipal purposes, obsolete, and of no value, and authorization is hereby provided to dispose of the following property:

Whelen 52” LED lightbar


SECTION 2. The property that is the subject of this Resolution shall be assigned to the CCSO or its designee, the property shall be received in “as-is” condition with no warranties or representations.

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its Committees that resulted in such formal action were in meetings open to the public and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.



That this Resolution shall be declared an emergency measure necessary to preserve the health, welfare and safety of the citizens of the Village of West Lafayette, Ohio the emergency being to enable the CCSO to fully equip its cruiser for service and shall be in full force and effect immediately upon its passage.
